

## **DANISH TRANSLATION LAUNCHED OF THE AVIATORS' MODEL CODE OF CONDUCT**

**Copenhagen, Denmark - February 7, 2006** - A Danish translation of the *Aviators' Model Code of Conduct* ("Vejledning til Flyvesikkerhed") was launched today by the Danish Flight Safety Council. Spearheaded by Claus Bak Petersen, M. Sc., Chairman of the Danish Flight Safety Council, the Danish translation presents broad guidance and recommendations to advance flight safety, airmanship and the vibrancy of the Danish General Aviation (GA) community.

The Danish translation is published as a brochure and is being distributed at every Danish airport, and published on the Danish Flight Safety Council website at [www.flightsafetycouncil.dk](http://www.flightsafetycouncil.dk) and [www.flyvesikkerhed.dk](http://www.flyvesikkerhed.dk). Furthermore, the Danish version will be published this spring in the flight safety magazine OY-SIK.

The translation was completed by the Danish Flight Safety Council. The Council is a non-profit organization focusing on flight safety, especially within GA. The Council is confident that this guide will encourage pilots to continuously focus on safety and good airmanship.

The *Aviators' Model Code of Conduct* (AMCC) is a voluntary, ethical code that presents diverse principles within its seven sections: (1) General Responsibilities of Aviators; (2) Passengers and People on the Surface; (3) Training and Proficiency; (4) Security; (5) Environmental Issues; (6) Use of Technology; and (7) Advancement and Promotion of General Aviation. To further the effective use of the Code of Conduct's principles, *Sample Recommended Practices* offer examples of how pilots might integrate the principles into their own practices.
